124/10 ABBOTSBROOK HALL

There were no matters to report

125/10 PAVILION/RECREATION GROUND

The resurfacing works to part of the drive have been completed. Works to the trees are to be done in early 2011 but will be funded from the 2011/12 budget as these works are fairly urgent.

126/10 BURIAL GROUND

a. Chapel Toilet

Mr Fitchew has spoken to Building Control at WDC and has been advised that there are no reasons to refuse the proposal to install a toilet in the

vestry, and that DDA compliance is not necessary. He was advised that an application for Building Control be made then, once received, to apply for planning permission.

It was suggested that other methods of sewage disposal be investigated besides a Klargester system such as a pump system and composting system. Members of the council will look at these methods and report back at the next meeting.

b. Heaters

The original quote received was for 2 x 3kw fan heaters at a cost of £948. We can obtain similar heaters with timers at a lower cost and install these ourselves. Another option would be infrared lamps. It was decided to investigate alternatives before coming to a decision.

127/10 NEIGHBOURHOOD ACTION GROUP (NAG)

Due to not receiving agendas in advance of the meeting, Mrs Morton has found it difficult to determine when her attendance would be useful as the content of the meetings rarely affect Little Marlow. The area also covers Wooburn and Bourne End and issues are generally more relevant to these areas.

A representative will attend as and when issues relevant to the Parish appear on the agenda and we will ask that we receive agendas in reasonable time, followed by the minutes.

128/10 ELECTORAL REVIEW OF BUCKINGHAMSHIRE

Responses are due by 22^{nd} November. We accept conformity to uniform size, but would want to have a say in the boundaries review.

a. Marlow Society

Parking on the field in the winter months is damaging the edges of the football pitch. A rope will be placed to stop cars driving onto the field.

c. River Users Meeting

Mr Mash attended this meeting at Henley Town Council and found it to be a very useful meeting. The issue of public moorings was discussed. He asked if the moorings at Spade Oak are public.

d. Winchbottom Lane

There has been more fly-tipping in Winchbottom Lane.

e. Westhorpe

Mr Mash reported that the manhole covers in Westhorpe have been stolen but have now been replaced.

There is a lot of rubbish on the bank between the A404 slip road and the road to Westhorpe visible from the Westhorpe side.

f. Parking on the Junction of School Lane and Church Road

It appears that this is still an issue.

g. Cemetery Chapel

The downpipe to the right of the chapel door is blocked. This will be cleared

h. WDC Rural Forum

Mr Emmett and Mrs Wallis attended this meeting.

i. Chepping Wye Valley LCP

Mrs Wallis attended this meeting. The feedback on the A4155 petition is on hold until after the inquest, but safer surfacing is being considered.

j. Parish Paths Walks
